





Don attempted to summit Mount Everest in 2016, paddled 750 miles across Canada in 2017, and recently hosted and directed *Surviving Mann*, a reality TV show where he along with MMA legend Randy Couture and the infamous Sherriff Lamb, produced very challenging courses involving intense physical training, long gun, pistol and shot gun shooting, land navigation, ropes courses and mission planning. The shows conclude with the members conducing a mission. He also has over 40 years (1,000 competitions) worth of competitive racing experience, and was once ranked 38th in the world as a triathlete.
